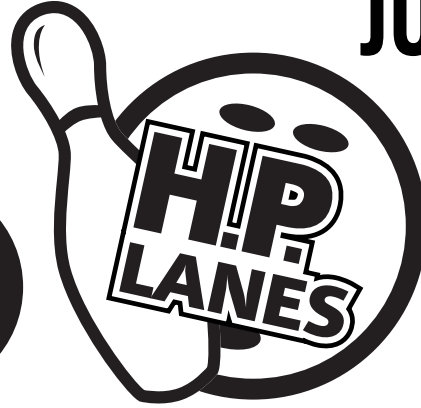

## BUCKEYE ALL EVENTS CHAMPIONSHIPS

1. This is a singles tournament open to the 2024-2025 All Events Handicap & Actual winners in both the Open and Women's Championship Tournaments in any Ohio State USBC affiliated local association where All Events Handicap & Actual are part of the local association tournament. The highest All Events Handicap & Actual bowlers of the tournament are the qualified entrants, whether or not they have entered the optional All Events Handicap & Actual. If the local association has two All Events Handicap & Actual winners (two divisions in a tournament) only the highest All Events scores will be eligible.
2. If a bowler wins All Events, either Handicap or Actual in more than one association: (a) they will represent the local association where they bowled their highest Handicap or Actual score: (b) the local association may send their next available All Events Handicap or actual bowler. An entrant may participate only once in the Buckeye ALL EVENTS tournament for each local association All Events Handicap or Actual Championship they win.
3. Any bowler arriving late shall begin play with the frame being bowled. No score for frames missed.
4. The tournament will be an actual and handicap singles event with four games bowled across four pairs of lanes. Handicap is 90% of 225. Scheduling will be done by the Ohio State USBC Buckeye All Events Chairperson.
5. The tournament will have 2 squads on Saturday June 7, 2025 at H.P. Lanes Columbus OH. Squad times are 11 a.m. and 2 p.m. The lanes will be dressed between shifts. Champions will receive a suitable award plus cash prizes. Cash prizes will be awarded 1 out of 5 ratio. In the event of a tie for 1st place, co-champions will be declared.
6. Bowlers must check in one-half hour before their scheduled start time.
7. If a qualified entrant is unable to bowl, they forfeit their entry fee.
8. Entries close May 20, 2025. If the All Events Handicap & Actual winners have not been determined by May 20, 2025, the previous year's winner may be entered provided they haven't competed under that title.
9. If the All Events Handicap/Actual winner is unable to attend, their local association may send the alternate next in line. If first alternate is unable to bowl, you may go down the line of All Events Handicap & Actual bowlers until a replacement is found.
10. Entrants are requested to wear suitable bowling attire.
11. All participants agree to allow the Ohio State USBC to use their photograph for publicity purposes. In the event the Ohio State USBC arranges for telecasts or broadcasts of the tournament, it would be without cost to participants and participants would not share any revenue derived therefrom.
